THE ENGLISH SHERRON FAMILY

This section briefly covers another Sherron family or families who came to America in the very early days. These families were of English origins. I have broken the family into two groups, but they were most probably related to each other, and of the same ancestry.

These families are not related to my Sharon family, at least not in this Country. The original Sherrons from Scotland mainly went to Ulster in Ireland, but a great many Scots went into England and southern Ireland as well. We may all be related way back when in the low counties of Scotland in the 1500s.

The big confusion to me came when this family and my Sharon family both appeared in Harrison County, Ohio at about the same time. It took a bit to sort them out, and in doing so I pieced out this history as best I could figure it.

I felt they were interesting and important enough to include in this family history.

JAMES SHERRON of NEW JERSEY

The area currently included in Salem and Gloucester Counties, New Jersey was part of the original lands given to William Penn to form his Colony in America. This area was in turn granted to a John Fenwick from England and became known as Fenwick's Colony.

John Fenwick was born in Northumberland County, England in 1618. He became a Quaker in 1665 and a follower of William Penn. Penn seems to have made certain land allocations, as most of what is now Southwestern New Jersey was under the ownership of one Lord Buckley.

In 1673, John Fenwick bought or otherwise obtained one-tenth of all the lands in Western Jersey from Lord Buckley.

It is worthy to note that people who purchased individual lands from Fenwick while he was still in England were exempted from the Quit Rent Rolls of New Jersey; those who purchased the lands once in the Colonies, were listed on the Quit Rent Rolls.

John Fenwick sailed from England and arrived to take possession of his new lands on October 5th, 1675. These lands included all of the present Salem County.

In 1676, another Englishman, James Sherron, came to America and took ownership of some 1000 acres in Lower Mannington. As he was exempted from the Quit Rent Rolls, he obviously made arrangements to purchase these lands while Fenwick was still in England.

I will try and detail this family beginning with James Sherron.

JAMES SHERRON

James Sherron Senior was probably born in Northumberland County in England about 1650. He came to New Jersey about 1676.

James was married to Mary Carary or Corary in the early 1700s, probably about 1705 as their son Roger was born in 1706. According to a history of the Gill Family in Colonial & Revolutionary Families of Pennsylvania, published in 1936 (see pages 128-131), Mary was a daughter of Roger and Elizabeth Carary. It states she was born in 1685. This would make her some thirty-five years the junior of James which is confusing. This may have been a James Sherron Junior. Not certain here at all, but it gets even more confusing in a minute, so hang in there.

There was a *Querie* in a Pennsylvania Genealogical Journal mentioning a James Sherron who married a Mary Tankersley. This can be explained by the fact that Elizabeth Carary remarried George Tankersley after her husband Roger Carary died in 1693. Her will mentions her daughter Mary Sherron and her grandson Roger Sherron, but Mary was a child of her first marriage to Roger Carary.

The Sherron family were early and loyal members of the New Salem Episcopal Church. James was quite prominent in the *Fenwick Colony* and was a sheriff in 1693 and a surrogate to the Court in 1716.

In 1707, James Sherron was appointed Overseer of the Poor in Mannington Township.

In 1717, James Sherron was murdered by a slave woman named Hagar and three others. All four were sentenced to death.

James died without a will and as his son, Roger, was only ten years old, Alexander Grant was appointed administrator of the estate. This would seem to indicate that Mary Sherron had also died by 1717 as she was not mentioned in the court records.

At any rate James and Mary Sherron had at least one child, Roger. There may have been another, possibly younger son as indicated in the next paragraph.

In a History & Genealogy of Fenwick's Colony by Thomas Shourds, there is mention that a daughter of Erasmus LaFette married a son of James's Sherron probably about 1730. It further said they had two children, Roger and Griffith Sherron. More confusion.

Problem is what was the name of James's son? I am assuming it was James Junior who probably died about 1732 in order for Roger to claim his father's estate. Remember this whole section is just one humongous guess.

James Sherron Junior (?)

If, and only if, the above mention of a Sherron marrying a LaFette gal is true, then there was another son in here somewhere.

As to the children being Roger and Griffith, this also makes no sense as the other son of James Senior married Rebecca Griffin and these names would appear to best be associated with Roger. I am going to list them as two children of Roger, with my fingers crossed.

At any rate I will list, half-heartedly at best, another son here.

Roger Sherron

Roger Sherron, according to a bible record, was born in 1706 and was therefore ten years old when his father died. Alexander Grant was issued papers to watch out for Roger's interest until he turned twenty-one.

In 1732, Roger Sherron took out letters of administration on his father's estate. In the same year he took out a license to marry Rebecca Wiggins.

In a 1733 deed, it mentions Roger and his wife, Rebecca, who was the daughter of William Griffin.

On November 23, 1727, David Wiggins married Rebecca Griffin. David died in May, 1731. It therefore appears Roger married Rebecca Griffin, the widow of David Wiggins.

In 1734, the *Pennsylvania House Minutes* contained references that one Roger Sherron residing in Salem County in the Jerseys was arrested and convicted of signing counterfeit Pennsylvania notes with a Robert Conway, an Irishman living in the Jerseys.

In 1735 Roger Sherron took residence in the *Common Goal* of New Castle County for his

crimes.

The next reference I found was in a family Bible in the possession of a Mrs. William Thompson Sherron of Germantown (Philadelphia), Pennsylvania as recorded in the Journal of the Pennsylvania Historical Society in 1941. This bible carried a publication date of 1741. The first entry states a birth; Corary Sherron, son of Roger and Eunice Sherron, born 12th August, 1755. The bible continues to record births, deaths and marriages through 1933 but no place names are given.

Obviously Roger got out of the hoosegow and started raising a family. What I find confusing is whether the above kids were with a new wife, or if they are a Roger junior's family. Roger senior would have been 50 years old in 1755 and it seems to much to expect of an ex-con. I am going with two Rogers here. Again only a guess.

Mrs. William Thompson Sherron of Philadelphia, was born Gertrude Gill and she is the one who wrote the various articles on the Sherron and Gill families from which I have obtained most of this information. She states that Roger and Rebecca had one child, Jane Sherron, who married Martin Carter in New Castle, Delaware. I feel she was mistaken and that Jane belonged to the Delaware Sharron branch outlined in the next section of this history.

If you look back at the questionable section on James Sherron Junior, those two children seem more logical if placed here.

I am guessing there was another Roger Sherron born about 1733. This Roger married Euniss Darvin on June 12, 1759 according to the Gill History.

According to published Bible Records in the Genealogical Society of Pennsylvania, reference to the bible owned by Mrs. William Thompson Sherron of Germantown, Pennsylvania, these births and marriages were recorded.

Children of Roger and Eunice Sherron:

CARARY SHERRON was born August 12, 1755.

JAMES SHERRON was born November 13, 1757. He married a Catherine.

REBECKAH SHERRON was born September 23, 1762. She married John Logue. The first Logue child was born in 1782. There is a record of a Rebecca Sherron marrying William Smith of Burlington in 1776. This may have been a first marriage, or another Rebecca all together.

HANNAH SHERRON was born July 27, 1764. She married John Cann in January 1789, and she died April 28, 1815.

This gets a tad confusing if Roger wasn't married until 1759. And especially since both sources are from records of Mrs. William Sherron who now seems confused at best. Oh well.

In the Gill History, she goes on to show that the above mentioned son, James, was the James Sharran of my family in Cumberland County. At that point I lost a bit of faith in Mrs. Sherron's research.

I have tracked down a few relatives of James Sherron still living in the eastern Pennsylvania area, but no one has more information. This family still retains the original spelling of Sherron but pronounces it as we do, 'Sharon.' The bulk of this family seems to have lived in the Philadelphia and Reading areas of Eastern Pennsylvania.

I know this is not very enlightening, but I put it in for sheer confusion's sake.

The Sherron Family of Delaware & Maryland

The first mention of the Sherron Family in Delaware was a William Sherron listed as a taxable in 1676 in Appogencus, New Castle County.

The next reference is to a James Shearon marrying Jane Armstrong in the Old Swede's Church in Wilmington, Delaware on March 6, 1758.

What if any bearing this has is questionable at best. At any rate the first Sherron in Delaware that I *can* track forward is Andrew Sherron.

Andrew Sherron seems to first appear in New Castle County, Delaware in the late 1700s. He was then in Queen Anne's County, Maryland shortly after 1800. Like James Sherron, this family was English and Episcopalian. It is uncertain whether they are related, but I frankly feel that they are.

New Castle County, Delaware lies right across the Delaware River from Salem County, New Jersey where the descendants of James lived. It would seem logical that Andrew was part of the New Jersey family who went off on his own in the late 1600s.

Andrew Sherron was born in 1781. He married Nancy Stephens, probably in Delaware in the late 1790s. Their son, John Sherron was born in Mount Pleasant, New Castle County, Delaware in 1804. The 1810 census shows the family in Queen Anne County, Maryland. By the 1820 census the family had moved to Stock Township in Harrison County, Ohio.

There was also a Stephen Sherron in both Maryland and Ohio so I assume this was Andrew's brother or more likely a cousin. In the 1810 census of Queen Anne County, Maryland shows Andrew and Stephen living next to each other.

The 1850 census of Stock Township, Harrison County lists a William Sherron age 70 (born in about 1780 in Maryland) and Michael Sherron living with him age 59 (born about 1791 in Virginia).

Continuing along in Ohio. Andrew's son, John Sheron, was born in Delaware on March 10, 1804 and he married Matilda Havenor in Harrison County on December 16, 1824.

There was a William Sheron who married Rachel Griffin in Harrison County on December 28, 1826. Both marriages were performed by Robert Orr, Justice of the Peace. They would appear to be brothers and sons of Andrew Sheron.

John and Matilda Sherron were the direct line of Sharon Bail and several others, and I have more information on them.

In January 2007, Sharon Bail sent me some info from a family bible record. It shows Henry Shearin was the father of Andrew Sherron. The record comes from a book *The Graham-Grimes Genealogy* by Frances Grimes Sitherwood.

HENRY SHEARIN, b. 25 March 1748 (*Bible*), according to tradition, in England. His father was a patter and he was a silversmith, but later a farmer. Lived in or near Baltimore, Md.; m. 27 Jan., 1780, Sarah Miller, b. 26 Jan., 1759; dau of William and Mary (Smith), b.

1715) Miller. Tradition says that they moved to Knoxville, Tenn., but not liking the rough neighborhood, returned to Baltimore where most of the children were born. Later removed to Brownsville, Pa., and after that to Waynesburg, Pa., where he d. in the first decade of 1800, leaving a widow and nine children. About 1810 the widow married George Graham, Sr., emigrant ancestor of the Graham-Grimes family.

Shearin Children

- I. Andrew, b. 28 Feb., 1781.
- II. William, b. 25 Dec., 1783; migrated to Indiana from Green Co., Pa.
- III. Mary, b. 5 Feb., 1786; m. Peter Graham, son of George Graham, Sr.
- IV. George, b. 27 Dec., 1789; probably m. a Miss Hughes. Living at Greenville, Ind., as late as 1854. A letter written by him at that to his nephew, Caleb J. Grimes, in the possession of the compiler, and thus it ends:
"I still feel determined by the grace of God to run the Christian race and keep my face Zionward, and search onward and upward till I reach that place held in reserve for all true followers of Christ. Now when you have read this letter reflect upon it and answer it as soon as practical. So I must come to a close by way of letter, but remain yours until death. Let your father read this letter, let all the connection read it."
- V. Nancy, b. 20 April, 1791; m. Nathan Hughes; d. in March, 1843, leaving eight children. She was the grandmother of Lucy Hughes, b. 5 April, 1843; m. James H. Babbitt, 25 June 1863; d. 19 June, 1910. (See 15).
- VI. Fruing, b. 8 Dec., 1793
- VII. Caleb, b. 1 March, 1796; m. --Hughes. Res. near Granville, Ind. A hatter by trade and a Quaker in religious belief. Lying very ill in May, 1854, according to letter above mentioned.
- VIII. Rebecca, b. 25 May, 1798; m. --Haley. Res. in Indiana
- IX. Henry Jr., B. 20 July, 1801. His fate was never known; he was either killed by Indians or in war.

Above records from the old Shearin Bible, written in the elegant handwriting of Henry Shearin, Sr. After the death of his widow, the Bible fell in the hands of the eldest daughter, Mary Shearing Graham. At her death it passed into the custody of her son, Caleb J. Grimes. Now in the possession of Frank B. Grimes, Dunns Station, Pa., -- great grandson of Henry Shearin, Sr.

This should establish Henry Shearin and Sarah Miller were the parents of Andrew.

At any rate I will start with Andy Sherron. The following information came from Sharon Bail also, but she did not know Andrew's parents at the time.

ANDREW SHERRON

Andrew Sherron was born in Delaware, probably in New Castle County, February 28, 1781. As the William Sherron in Harrison County in 1850 was born around 1781, they would most likely be brothers. In the above information on Henry and his children, there was a son William born December 25, 1873.

Andrew married Nancy Stephens in Delaware in about 1800. Most likely in Mount Pleasant, New Castle County as that was where their son, John, was born in 1804.

The family was in Queen Anne's County, Maryland in the 1800 census, Greene County, Pennsylvania in 1810 and in 1820 they were in Short Creek Township of Harrison County, Ohio.

According to a descendent, they moved into Pennsylvania in 1817 and into Harrison County, Ohio in 1819.

As near as I can figure, the family, or at least the sons, of Andrew and Nancy Sherron were:

John Sheron

John was born in Mt. Pleasant, New Castle County, Delaware on March 10, 1804. He married Matilda Havenor in Harrison County, Ohio on December 16, 1824.

Matilda was born near Harper's Ferry in Virginia on September 16, 1808. She was a daughter of Dominick Havenor or Havener and Martha Upton.

According to articles in the MARION (Indiana) CHRONICLE, John came to Ohio in 1819 with his parents. During the 1820s, John and Matilda moved to Perry County, Ohio. By the 1840s, the family was in Hocking County, Ohio.

He was a farmer and a cooper by trade.

In 1854 he moved with his family to Grant County, Indiana. They settled on Hummels Creek in Pleasant Township. His wife, Matilda, died in 1876 and John remarried to a Nancy Davis. John died in April of 1889 after retiring to Marion, Indiana.

John and Matilda's children were:

WILLIAM SHERON was born April 3, 1826 in Harrison County, Ohio. He was a shoemaker. He moved with his 'boss' to Nauvoo, Illinois. He married Prudence Adeline Gifford on July 2, 1848 in Nauvoo. She was born in Pennsylvania on December 12, 1827. He moved to Louisa County, Iowa until the mid 1860s and then returned to Grant County, Indiana and fought in the last year of the Civil War. He remained in Grant County and was both a shoemaker and a farmer. Prudence died August 12, 1879, probably exhausted from having all these children. William was alive when the History of Grant County was published in 1912. I have since found out that he died in Marion, Indiana on July 26, 1920. His children were:

Albert F. Sheron born November 19, 1849 and died the same day.

Joseph A. Sheron born September 30, 1851.

George Sheron born October 14, 1853 and died March 26, 1854.

Sarah Sheron (?) born in 1854.

Edward Sheron a twin born March 4, 1855 and died October 2, 1856.

Edwin Sheron the other twin and he died October 23, 1855.

Elizabeth Sheron born February 6, 1857. She never married

John Sheron born May 5, 1859.

Matilda Sheron born February 3, 1861. She married a Livingood man.

Lydia Sheron born November 28, 1862.

Laura J. Sheron born October 21, 1864.

Thomas Sheron born June 17, 1867.

William E. Sheron born October 28, 1869 and died March 8, 1881.

MARY ANN SHERON was born November 19, 1827. She married Thomas Crawford in Hocking County on September 7, 1847.

JAMES SHERON was born October 10, 1830 and died June 2, 1903. He married Nancy Lytle in Hocking County, Ohio on January 13, 1853. He took over his father's farm and remained in Pleasant Township of Grant County, Indiana until he retired to Marion, Indiana. He had eleven children, note spelling of Sharen:

John A. Sharen born December 7, 1853 and died April 25, 1923. He married Elizabeth Thompson.

Thomas Sharen born in 1857.

Benton R. Sharen born in 1859. He married Margaret (Maggie) Mathias in Grant County on April 13, 1882.

Thessa Sharen born in 1862.

William Sharen born in 1864.

Levi Sharen born in 1866.

Lemuel Sharen

Matilda Sharen married Albet Stevens.

Edward Sharen

Anna Sharen married LeRoy Prickett

LUCINDA (SINDA) SHERON was born October 2, 1831. She married William Lytle in Hocking County on March 27, 1851. Their children were:

John Lytle born in Ohio in 1854.

Matilda Lytle born in Indiana in 1855.

Thomas Lytle born in Indiana in 1858.

Hugh Lytle born in Indiana in 1861.

William S. Lytle born in Indiana in 1867.

Mary A. Lytle born in Indiana in 1869.

RACHEL SHERON was born September 17, 1833. She married George Pontius in Hocking County on January 30, 1851.

BERNARD (BARNEY) SHERON was born November 10, 1835 and lived in Marion, Indiana. He married Victoria M. Helm in Grant County on May 10, 1859. He enlisted in the Indiana Infantry in 1864 and served through the end of the Civil War. Victoria died March 27, 1886 and he remarried Christina Hall in about 1890 in Grant County. Barney died in Marion on November 17, 1925. Christina died February 6, 1926. His children were:

Francis Marion Sherron born July 7, 1861 and died December 17, 1937. He married Martha S. Gardner August 16, 1886.

Charles Louis Sherron born March 11, 1863 and died November 1, 1939. He married Rosetta Atkinson on September 11, 1884.

Thomas Sherron born December 17, 1864 and died ten days later.

Cinderella Rebecca Sherron born April 11, 1866 and died July 12, 1934. She married George Miller August 2, 1881.

Floyd Columbus Sherron born August 12, 1868 and died on March 23, 1888 when a tree fell on him. He married Lizzie Williams two months before his death on February

5, 1888.

Ruth Anna Sherron born September 7, 1870 and died February 17, 1952. She married Harrison Oliver September 19, 1885 and he died shortly thereafter. Then she married Samuel Jay Bradbury on May 13, 1888.

Albert Leroy Sherron born February 4, 1872 and died September 27, 1942. His wife was named Mattie.

Luther Pleasant Hess Sherron born November 17, 1875 and died October 5, 1950. He was twice married. His second wife was Florence.

William Allard Sherron born January 15, 1878 and died about 1955. He was married twice. He married Vera Naugle in Sandusky County on January 24, 1920. I don't have the other girl's name.

Delos Lacy Sherron born October 26, 1880. He was married three times, his first wife was Maude.

Harlie Clyde Sharon (note spelling) born August 15, 1883. His wife was Elizabeth.

SARAH (SALLY) SHERON was born July 22, 1837 in Perry County, Ohio. She married John Endsley in Grant County, Indiana on April 5, 1857.

NANCY SHERON was born January 1, 1847. She married James Stakely in Hocking County on March 22, 1859. She later married Alexander Moorehead in Indiana.

JOHN W. SHERON was born July 23, 1847. He married Rebecca Lanning in Hocking County on June 20, 1862.

MATILDA SHERON was born February 8, 1850.

NEONA J. SHERON born in 1853 in the 1860 census.

WILLIAM SHERON born in 1855 according to the 1860 census.

Andrew Sheron Jr.

Andrew Sheron was born in Maryland in 1815. He appears in the 1850 census of Newton Township in Muskingum County, Ohio and in the 1860 census of Swan Township, Vinton County, Ohio. This area is adjacent to Hocking County where the rest of the family was.

I have a marriage record Andrew marrying Mahala Strate in Perry County on May 24, 1846. She must have died soon thereafter, as on June 14, 1849 he married Catherine Barnet also in Perry County. Catherine was the wife listed in both the 1850 and 1860 census reports.

They were in Muskingum County, Ohio in 1850 and Vinton County, Ohio in 1860, and was shown as being a potter in both reports. In both reports, he lists Maryland as his birthplace. This fact conflicts with earlier information I was given that he was born in New Castle County, Delaware. In fact this may mean there were more than one Andrew Sherron and this Andrew I am listing, may well be the Andrew who was a son of Henry Sherron and who was in Greene County, Pennsylvania in 1800 and 1810.

At the time of the 1860 census the children were:

ANNA SHERON born in 1850 but not in the 1860 census.

MARY E. SHERON born in 1851.

ELIZABETH SHERON born in 1852.

RACHEL SHERON born in 1853. There is a record of a Rachel E. Sheren marrying Setstheel Auker in Hocking County on April 9, 1873.

William Sheron

William Sherron was probably born about 1807 in Delaware. He married Rachel Griffin in Harrison County, Ohio on December 16, 1826.

Then he may have died as there is a marriage record of a Rachel Griffin marrying Francis Danison or Donaldson November 1817, 1837.

I have very little more except there is a marriage record in Hocking County, Ohio for Stephen Sheran and Miranda Hudson on March 30, 1843. If he went to Hocking County with his father then Stephen might be a son.

Elizabeth Sherron

Based on an article in the History of Tuscarawas County, Ohio, Elizabeth was born in Maryland on October 23, 1812. It stated she was a daughter of Andrew and Nancy Sherron.

She married John Bremer in Tuscarawas County on March 10, 1834.

This is all I have.

Warren or Warner Sheron

This guy pops up in letters from two other researchers. I have a copy of his death record in Eaton County, Michigan. According to this document he was a son of Andrew and Nancy Sheron. This would place him here in this family. There should have been four sons according to earlier census data and this makes four. The right four I hope.

He was born in Ohio on September 5, 1819 and died in Indiana, Michigan of diphtheria on November 15, 1875.

He married Mary Francisco in Hocking County, Ohio on June 15, 1845. They were in Noble County, Indiana for the 1850 census and in Eaton County, Michigan in 1860 and 1870.

Matilda Sherron

I find a marriage record of Matilda marrying Peola Bremer in Tuscarawas County on May 20, 1849. This would probably place her birth about 1828 to 1830.

I am placing her here based on what I found out about Elizabeth in the History of Tuscarawas County. Since they both married into the same family, I guess them to be sisters.

Another Henry Sharon

Here's a kicker. We have John and Matilda Sherron in Washington Township of Hocking County, he being age 45 born in Delaware. We also have Henry Sharon in nearby Falls Township of Hocking County.

Henry is 35 and born in Virginia. His wife Catherine is also 35 from Virginia. They have Andrew 11, Nancy 8, John 6, Lucy 4 and Thomas 1 all born in Ohio.

Barbara Grenier has added this info:

“Henry was enumerated next to the James Lannings. Their daughter Jennetta married Joseph Sheren in 1851. Joseph was born in Harrison County Ohio (Civil War enlistment papers). This connection might solve a lot of questions.

I am very interested in this family. In 1860 they are still in Hocking Co Ohio but in Green Township which is near Falls Township. In 1870 they are in Illinois, in Cartwright, Sangamon County. In 1880 the oldest child, Andrew or Andy on census is still in Illinois in Pleasant Plains, Sangamon County, a widower with three daughters.”

Miscellaneous Sheron, Sherren, etc. Marriages in Ohio

The following marriages are all probably related to this family, but as of right now I do not know exactly how. I am listing them simply because they took place in either Hocking County or in counties that abutted Hocking.

Alvina Sherren & Jacob Hoyt June 18, 1885 Hocking County. Barbara Grenier also added this and later info: “Alvina (Mary Alvina) Sherren born 7 July 1862 & Jacob Hoyt (sic) Hoy married June 18, 1885 Hocking County. She was a daughter of Joseph Sherren and Jennetta Lanning. Sallie (Sarah Ann) Sharron born 7 Jan 1858 and David Rush married 7 Oct 1877 in Hocking (my great grandparents) she was a daughter of Joseph Sherren and Jennetta Lanning; s/o of David Rush and Nancy Allen. Joseph Sherren and Jennatta Lanning had a daughter, Nancy (the last child) b. 2 June 1864. She married Eli Rush as his second wife.”

Catherine Sheron & Simon Hoffe December 22, 1850 Carroll County.

Catherine Sheron & James Mahon February 25, 1805 Ross County.

Emma Sheron & Samuel Auker September 8, 1881 Hocking County. “Emma (Mariah Emmaline) Sheron b. 23 May 1860 & Samuel Auker September 8, 1881 Hocking County. She was a daughter of Joseph Sherren and Jennetta Lanning.”

Frank Sheeran & Sarah C. Crosbie September 5, 1876 Perry County.

George Sheron & Mary Ann Cooney June 13, 1847 Hocking County.

George Sheeran & Caroline Hamilton August 9, 1877 Perry County.

Hugh Sheeran & Catherine McGonagle November 8, 1863 Perry County.

James Sheeran & Ann Crosbie October 13, 1874 Perry County.
